### **1.3.1 General**

1.3.1.1 Face page, index and introduction sections updated appropriately for the new version

### **1.3.2 Chapter 10**

1.3.2.1 In V20.1, add new transaction types to 10.1.7 description of Stock Movements.

1.3.2.2 In V20.1, update 10.2.18 for ASBN which can now be used to create a Term DBV Substitution transaction as well as a Repo Substitution transaction.

### **1.3.3 Chapter 11**

1.3.3.1 Update the introduction to cover both overnight and term DBVs. Further updates to the introduction in V20.1.

1.3.3.2 NDDN - remove version 3, add version 5 to include fields RETURN DATE and MARK TO MARKET. APPLY BOE HAIRCUT also added to version 5 in V20.1.

1.3.3.3 NDDQ/NDDP - remove version 3, add version 5 to include fields RETURN DATE and MARK TO MARKET in the response. APPLY BOE HAIRCUT also added to version 5 in V20.1.

1.3.3.4 In V20.1, NVTQ/NVTP - remove version 2, add version 4 to include APPLY BOE HAIRCUT.

1.3.3.5 In V20.1, include template CT0215 for messages NTAN Term DBV Adjustment Input, NTAQ/NTAP Term DBV Adjustment Retrieve and NTTQ/NTTP Term DBV

Transaction Retrieve.

### **1.3.4 Chapter 12**

1.3.4.1 ARPQ/ARPP - remove version 1, add version 2 to include SELECTION TERM REPOS, SELECTION OPEN REPOS, SELECTION TERM DBVS, SELECTION DATE FROM, SELECTION DATE TO AND SELECTION ALERTS ONLY in the request; include BASE COLLATERAL VALUE, MARK TO MARKET, DBV CLASS, ACCOUNT ID, TERM DBV INTEREST TRANSACTION ID, DBV CONCENTRATION LIMIT, TRANSACTION TYPE, TDO ALERTS, LAST COLLATERAL VALUE and GIVER OR TAKER in the response and CONCENTRATION and TDR ALERTS in the response for the returns.

1.3.4.2 In V20.1, add APPLY BOE HAIRCUT to ARPP for version 2. Make TDR Alerts 'O' on ARPP message.

1.3.4.3 In V20.1, NDDD can also be used to delete a Term DBV Adjustment instruction.

### **1.3.5 Chapter 17**

1.3.5.1 BSBQ/BSBP – remove version 2, add version 4 to include fields REPO BALANCE COLLATERAL OUT and REPO BALANCE COLLATERAL IN in the response. REPO BALANCE renamed REPO BALANCE SCR.

1.3.5.2 Add new messages AOCQ/AOCP to CT0005. CONSIDERATION made Optional on AOCP in V20.1.

1.3.6.1 For V20.1, include term DBV transactions in Exposure description.
